- 1. Welcome and Introduction: Tom Neufeld (Chair) welcomed everyone in attendance. Tom thanked Janice and Helen for arranging the refreshments available to residents who attended the recent AGM on the 24 April 2025.
- 2. Minutes: JM proposed minute and DB seconded this.
- **3.** *Matters arising from last meeting minutes:* TN highlighted an error under Section 10. Contract Co-Ordinator Report paragraph 4, that the hedges in Area 32 and 34 had been reduced to fence height, and advised to delete from the minute that the fence was removed.
- **4. Park PM Update:** E Adams, PPM representative, was not in attendance, it was confirmed that emails had been sent to residents advising of the annual fees, and that letters will follow in due course.
- 5. Councillor Update/Questions: No Councillor in attendance.
- **6. Questions from Residents:** LS raised concern about the steps at Beechwood Dr. TN said he and RG would take a look, however he believes the steps belong to the WDC.

DB asked if there was an update on the repair of the manhole cover at the entrance to the estate. TN advised that he had been included in emails JB has sent to WDC and Scottish Water. JM suggested spray painting around it and TN said he would check if had spray paint.

LP requested that the meetings are held remotely on either Zoom, or MS Teams, after discussion it was agreed that at this time this isn't possible, there is no wifi in the building, but it is something that can be reconsidered at a later date.

TN advised that the hall used for the monthly Beechwood and Wheatcroft Residents Association is due to be refurbished and we may experience some disruption over the next couple of months.

KS asked if there was an update from the agreement at the last meeting in March to purchase cameras. DB said he couldn't find the clamps required to fit the cameras to the lamp post. AM suggested using heavy duty tie-ups.

Proposed sites to place the cameras are the substation in Broomhill Drive and the lane at the footpath at Highdykes.
